

# **2026 Fall Semester Application Guidelines for Exchange Students**

## **Faculty of Science, Niigata University**

April 2026

Faculty of Science at Niigata University provides students from partner universities with which it has concluded student exchange agreements with opportunities to study various subjects and/or Japanese language and society for a semester or two. The exchange students are expected not only to study those subjects but also to develop their capabilities to contribute to the globalizing world in studying and living in different social settings.

### **Eligibility**

An applicant must meet all of the following requirements.

- (1) The applicant is currently a regular student at the undergraduate or Master's level at a university with which Niigata University has concluded a student exchange agreement between the Universities or between their departments (hereinafter referred to as "partner university"). (Students who already have graduated from the partner university at the time of enrollment in Niigata University are not eligible.)
- (2) The applicant has good academic records, has sufficient language proficiency for effectively taking the course he/she plans to take, and thus obtain a Letter of Recommendation from the head of his/her department or from his/her academic advisor.
- (3) The applicant is in a sufficient physical and mental condition for effectively participating in the program.

### **Semester Term**

Each applicant starts their studies at Niigata University in fall 2026 for either one or two semesters. (Students who cannot complete semester's study at Faculty of Science of Niigata University are not eligible.)

Fall Semester 2026: October 1, 2026 – February 28, 2027

(They will normally end in early February.)

Spring Semester 2027: April 1, 2027 – August 31, 2027

(Classes start on early April. They will normally end in early August.)

### **How to Apply**

This student exchange is conducted in accordance with agreements between Universities, not as an arrangement between an individual student and Niigata University. Therefore applications to Faculty of Science, Niigata University must be submitted to the office in charge of exchange students at the applicant's home university (a partner university of Niigata University), not directly to Faculty of Science of Niigata University. The partner university subsequently sends the documents specified below to the Student Affairs Office of Faculty of Science, Niigata University by postal mail. Applications submitted directly by individual applicants are void.

※ By Japanese immigration laws, international students with “student visa” are required to have more than a total of 10 hours (600 minutes) of class sessions per week. Since each class session of Niigata University is 90-minutes long, international students must register enough subjects to have at least 7 class sessions per week. ## Academic Results and Credit Transfer

- (1) An official academic transcript will be issued upon completion of the program. The transcript will include course names, results, and the number of credits earned.
- (2) Based on the transcript issued by Faculty of Science, Niigata University, students' home university will determine whether to accept transfer of credits. Students are strongly advised to consult their home university regarding credit transfer before applying to this program.

## Part-time Jobs

An exchange student with a Student Visa is prohibited to work in Japan in principle. On certain strict conditions (type of work, working hours per week, etc.), the Immigration Bureau may give him/her a working permit (Permission to Engage in Activity Other than That Permitted under the Status of Residence Previously Granted).

In addition, Faculty of Science at Niigata University advises that exchange students do not do a part-time job because studying is an utmost priority for them. If an exchange student wants to do a part-time job, please first consult his/her Advisor Professor and Student Affairs Office. Niigata University may grant permission to the student when the following three conditions are satisfied: (i) The student studies at Niigata University for TWO semesters. (ii) There are rational reasons. (iii) The engagement is during a long break period.

However, exchange students are exempted from permission for working with honoraria as a teaching assistant or a research assistant in the campus or in an international exchange or education activity on and off campus.

## Admission Procedures

- (1) On behalf of students who have been admitted, Niigata University will submit students' Application for Certificate of Eligibility for Entry into Japan to the Immigration Bureau of Japan. Upon receiving an electronic version of COE from the Immigration Bureau, Faculty of Science of Niigata University will forward them directly to exchange students by e-mail. After receiving the e-mail, students should apply for a visa at Japanese Embassy or Consulate in their country by submitting required documents including COE (electronic version), which will help expedite visa issuance. With this electronic version of COE, a visa is issued swiftly and also the entry into Japan at a port of entry is permitted swiftly because the Immigration Bureau has already recognized the eligibility of the student for his/her entry into Japan with the accepting Niigata University's request.
- (2) Admitted students may apply for accommodation for international students (Co-op Leased Apartments Supported by Niigata University) before arriving in Japan. In addition to the assistance provided by Co-op, Niigata University will support you by paying the part of the initial cost. (Rents vary depending on the apartment room). Details will be announced after students are admitted.
